Provincial Peer Training Curriculum



The value of peer support in the context of mental health, addictions, and responding to the overdose emergency cannot be overstated.

Peer supports can be found in every facet of mental health and substance use (MHSU) services, providing invaluable care and advocacy to a range of communities and populations. Provision of peer supports takes place in K–12 schools, correctional centres, post-secondary institutions, family services, overdose prevention sites, hospitals, and anywhere else that overlaps with the broader MHSU sector. People with lived/living experience have been at the forefront of innovation, driving best practices and effecting policy change at all levels of government.

In April 2019, BCcampus received funding from the Ministry of Mental Health and Addictions (MMHA) to develop, implement, and evaluate a provincial peer training curriculum and standards of practice (SOP). The goal of this project is to enhance peer support program quality and uniformity across the province by delivering educational resources that are accessible, evidence-based, and consistent with the emerging trends in the field of mental health and addictions.



This is a priority action in the the *Pathway to Hope: A roadmap for making mental health and addictions care better for people in British Columbia*. This action reflects the commitment and leadership from the Ministry of Mental health and Addictions (MMHA) to address peer support training and resource gaps.

The purpose of this project is to develop a peer support training curriculum and educational resources that:

- Are informed and evaluated by existing peer support organizations and persons with lived experience in B.C.
- Recognize the valuable contributions that peer support workers make in supporting people in healing, harm reduction, and recovery.
- Are informed by Indigenous Peoples so that they are culturally safe and embrace Indigenous perspectives on healing and wellness.
- Incorporate the policy and practices principles described within the B.C. Ministry of Mental Health and Addictions Pathway to Hope Strategy.
- Are available to employers and post-secondary institutions who would like to offer provincially approved training, free of charge.
- Reflect the diverse needs of the population through application of a Gender-Based Analysis Plus.

Phase 1

April 2019 – August 2020

Approved B.C. Provincial Standards of Practice and a Curriculum Guide produced.

Phase 2

August 2020 – January 2021

Tools/resources for peer support worker training developed and prepared for piloting.

Phase 3

January 2021 - March 2021

Evaluation and revisions to the tools/resources through pilot with participating organizations.
